9 REQUEST FOR BAIL

10 The State requests bail in the amount of \$100,000, pursuant to CrR 2.2 (b) (2) (i), (ii),  
11 (iii), and (iv). The amount set at first appearance was \$100,000 and the defendant bailed out at  
12 that amount. He is represented by counsel.


13 The defendant is a clear danger to children given the circumstances of this crime where  
14 he abused his position of trust as a first and second grade teacher, secretly molesting these girls  
15 in class in front of others.

16 The defendant has lived in the State of Washington only 20 months. He has no criminal  
17 convictions in Washington. He has two misdemeanor out-of-state convictions: Simple  
18 Possession (TN 2006); and Damage – Domestic Violence (NH 2007). He has now lost his  
19 employment at the private school.

20 The defendant also may face a 25–year minimum term enhancement if a jury finds these  
21 offenses were predatory under RCW 9.94A.836.

22 The State also requests a no contact order be issued for the protection of [REDACTED] and  
23 minors.

That Michael Moore is a Detective with the Seattle Police Department and has reviewed the investigation conducted in Seattle Police Department Case Number 2013-135935;

There is probable cause to believe that Jordan Eareckson Murray DOB: 9-17-1980 committed the crime(s) of Child Molestation RCW 9A. 44.083 within the City of Seattle, County of King, State of Washington.

This belief is predicated on the following facts and circumstances:

On 4-23-2013, the Seattle Police Department received two CPS referrals regarding two females, [REDACTED] that had reported they were touched sexually by their teacher. The girls identified the teacher as Jordan Murray. The girls attend a private school located at: 3528 S. Ferdinand St. Seattle, WA.

Jordan Murray is a thirty two year old male. He has been employed as a 1<sup>st</sup> and 2<sup>nd</sup> grade teacher at the private school located at 3528 S. Ferdinand St. Seattle, WA since the beginning of the 2011 school year. Murray teaches a 2<sup>nd</sup> grade class in the morning. After the lunch recess, Murray moves to the 1<sup>st</sup> grade classroom. On placards outside the two classrooms, Murray is listed as Rabbi Yaakov Murray. The children identify Murray as Rabbi Murray. The administration at the school advised me that Murray has not received formal rabbinic ordination and the school use of the title Rabbi was merely honorary.

[REDACTED] is a six year old female. [REDACTED] was interviewed by the King County Child Interview Specialist. [REDACTED] is a student in Murray's 1<sup>st</sup> grade class. She stated Murray puts her on his lap and has put his hand down her pants. She stated the touching has occurred more than 1 time. It has always occurred in Murray's first grade classroom while he is at his desk. [REDACTED] described the most recent incident. She approached Murray's desk to show him her school work. Murray pulled her toward him and placed her onto his lap. He was seated in his chair. Murray placed his hand underneath [REDACTED] outer clothing and underwear. Murray touched [REDACTED] vaginal area. She described Murray as just putting his hand there. He did not say anything or make any sounds. She could only see his arm. His face was looking at her work. [REDACTED] does not believe anyone saw the incident as Murray's desk blocks the view. [REDACTED] said she tried to think about her work and tried to ignore it. The contact ended when Murray removed his hand from [REDACTED] underwear.

[REDACTED] described another incident, when Murray placed his hand up her shirt and touched her chest area. [REDACTED] was not wearing a shirt underneath her outer shirt. Murray placed his hand up her shirt and then moved it back down and out. She demonstrated the touching by placing her hand on her right breast area. She referred to it as "another private area." There were other children in the classroom though no one saw the incident because Murray's desk blocked the view. [REDACTED] stated the touching always occurred in the classroom. She could not recall how many times Murray placed his hand down her pants. She stated he has done it more than one time. She said Murray put his hand up her shirt one time. [REDACTED] stated the touching made her feel strange and uncomfortable.

eventually told her older sister about the incidents. She then told her mother.

is a seven year old female. was interviewed by the King County Child Interview Specialist. is a student at the school located at 3528 S. Ferdinand St Seattle, WA. is in Murray's second grade class. She stated that her teacher was doing inappropriate things to her. She identified the teacher as Rabbi Murray. She stated it has happened more than one time. She stated the last time happened, "before yesterday." said Murray touched her private area and it did not make her happy. She was standing next to Murray at his desk while he checked her work. She stated he touched her private area; pointing to her vaginal area. Murray was seated in his chair. He used his hands and she believes the touching occurred underneath her outer clothing and underwear. She did not know what his hand was doing. She stated the touching always occurred in class. Other children were present but they couldn't see because of Murray's desk. Murray does the same thing everytime. She stated the touching started during the middle of the school year.

said she told her friend They reported it to sister They then reported it to mother, stated Murray's touching her started this school year. She had Murray as a teacher last year also.

is a six year old student at the school located at: 3528 S. Ferdinand St. Seattle, WA. She stated Rabbi Murray lets kids sit on his lap sometimes though "we really shouldn't." When we feel sad he is nice stated the last time she sat on Murray's lap was just before he got the flu. The next day he got the flu and he has not come back to school.

stated she was standing in front of Murray, between his legs. She said sometimes he is sitting in his chair, sometimes he is leaning back in his chair Murray wraps his arms around her. His hands are over her clothing and not moving around. said she was facing away from Murray when he would hug her. She stated he has done it more than 1 time. When he is done he tells her to, "Do your work." also said she sits on Murray's lap, facing away from him. She recalled seeing a table in front of Murray's desk and there were other kids in the classroom when it happened.

recalled seeing other children sitting on Murray's lap. She mentioned (unknown last name) specifically sitting on Murray's lap. She didn't want to talk about it any further.

works as a at the private school located at: 3528 S. Ferdinand St. Seattle, WA. She has worked at the school since 2012. She works 7:45am to 4:15pm Monday through Friday. Her duties include: She will assist teachers in their classroom occasionally. She has not worked in the 1st and 2nd grade classrooms.

Her desk is located Students will come to her desk for assistance. stated that students have been coming to her desk since early in the current school year complaining of stomach aches, headaches and general nervousness. recalled six girls in particular that have complained to her multiple times: (1st grade), All of the girls were

Murray's students. The girls had similar complaints of anxiety, stomach aches. The 1st grade girls were upset around the lunch hour and reluctant to go to recess and to their afternoon class. After the lunch recess, Murray moves from his 2nd grade classroom to the 1st grade classroom. [redacted] had notified parents of the children's complaints. They often reported that when the children were taken home early and returned home, they appeared fine and acted normally.

[redacted] stated [redacted] recently disclosed to her that she does not like to come to school. She said her stomach hurt and she was nervous. [redacted] said, "Bad things happen at school." [redacted] stated bad things happen, I don't understand. I can't tell you. I get scared and nervous. [redacted] would talk about friend's problems. No details provided. [redacted] disclosed to [redacted] that "Rabbi" Murray makes her nervous. He makes her uncomfortable. [redacted] has refused to go to class and has spent her afternoons at [redacted] desk.

[redacted] also recalled that Murray had brought [redacted] to the office. [redacted] is in Murray's second grade Karen Robins- Principal handled the situation. The following day, Murray telephoned at the school. He asked what was going on with [redacted] and asked if anything had happened. [redacted] thought the call was unusual as Murray had the day off and he has never called her before asking about a specific child.

[redacted] is a 12 year old student at the school located at 3528 S. Ferdinand St. Seattle, WA. She is [redacted] older sister. She has not had Murray as a teacher while at the school. However, she does know Murray and his family as she has babysat for them in the past. The Murrays have two boys ages 6 and 5 and a girl approx 1 1/2 years old. [redacted] that several weeks ago, her sister [redacted] and her sister's friend, [redacted] were playing at [redacted] home. The girls came to speak with [redacted] She noticed they were acting strangely. They approached her and whispered that Rabbi Murray puts his hands in their pants. [redacted] questioned the statement. The girls responded that they discussed it before and they were scared. They didn't know why it happened and they are confused as to why it is happening. [redacted] told [redacted] not to tell their father, [redacted] They also did not want the teacher to know. The children told [redacted] the touching was in their underwear.

[redacted] brought the children to her mother [redacted] They told her what had happened. The girls said they were being honest and they were telling the truth. The girls mentioned a book they have seen and read called the Let's Stay Safe book. The book deals with safety rules and is used at the school and in [redacted] home.

Jordan E. Murray declined to provide a statement.
